SOUTH FLORIDA AND TREASURE COAST WEEKLY LANE CLOSURES AND WORK ZONE ADVISORY

FORT LAUDERDALE — Florida's Turnpike announces updated lane closures and work zones due to construction and maintenance projects in Miami-Dade, Broward, Palm Beach, Martin and St. Lucie counties, **for the week beginning Sunday, Aug. 9.**

MIAMI-DADE COUNTY

TURNPIKE – MILLING AND RESURFACING PROJECTS (MILEPOST 0-9, 11-16 & 20-22)

- One or two **northbound** Turnpike lanes will be closed on various segments of Florida's Turnpike from the Southwest 216th Street (Exit 11) interchange to the Coral Reef Drive/Southwest 117th Avenue (Exit 16) interchange from 9 p.m. to 5 a.m. Sunday, Aug. 9, through Thursday, Aug. 13. At least one northbound lane will remain open.
- One **southbound** Turnpike lane will be closed on various segments of Florida's Turnpike from the Allapattah Road (Exit 9) interchange to the South Dixie Highway/U.S. 1 (Exit 1) interchange from 9:30 p.m. to 5:30 a.m. Sunday, Aug. 9, through Thursday, Aug. 13. At least one southbound lane will remain open.

PROJECT DESCRIPTION: Two construction projects are underway to remove the existing pavement and to resurface and restripe various segments of the Turnpike: from the U.S. 1 (Exit 1) to Allapattah Road (Exit 9); from Southwest 216th Street (Exit 11) to Southwest 152nd Street/117th Avenue (Exit 16); and from Southwest 88th Street/Kendall Drive (Exit 20) to Southwest 56th Street/Miller Drive at Milepost 22. New shoulders will be constructed on the ramps at the following interchanges: Campbell Drive, Biscayne Drive, Tallahassee Road and Allapattah Road. The existing paved shoulders will be widened at the ramps to U.S. 1 and to Biscayne Drive. One project is scheduled for completion by the end of 2009; the other is scheduled for completion in the summer of 2010. Combined cost: \$14.4 million.

TURNPIKE – SOUTH FLORIDA INTELLIGENT TRANSPORTATION SYSTEMS (ITS) PROJECT

- No lane closures this week.

PROJECT DESCRIPTION: Data collection equipment, including cameras, vehicle detectors and travel-time detectors, along with two electronic, dynamic message signs (DMS) are being installed on Florida's Turnpike from Milepost 0 to Milepost 117 and from Milepost 0X to 4X. The equipment will help the Turnpike's Traffic Management Center identify and manage traffic incidents. The project is scheduled for completion this summer. Approximate project cost: \$20.6 million.

OKEECHOBEE TOLL PLAZA OPEN ROAD TOLLING AND NW 74TH STREET INTERCHANGE (MILEPOST 32)

- One Turnpike lane in each direction will be closed north and south of the Okeechobee toll plaza from 10 p.m. to 5:30 a.m. Sunday, Aug. 9, through Thursday, Aug. 13, for sign removal and drainage related activities. At least one lane in each direction will remain open.
- **All northbound** Turnpike traffic between Bird Road/Southwest 40th Street (Exit 23) and the Okeechobee toll plaza will be **slowed to 15 mph** for approximately 20 minutes at a time between 11:45 p.m. Monday, Aug. 10, and 2 a.m. Tuesday, Aug. 11, for installation of a sign assembly.

PROJECT DESCRIPTION: The Okeechobee mainline toll plaza will be converted into an open-road tolling plaza that will allow motorists with SunPass to travel at highway speeds while their toll is collected via SunPass equipment overhead ... no gates, no tollbooths. Cash-paying motorists will pull off the highway onto ramps with traditional tollbooths and then merge back onto the travel lanes. A new SunPass-only interchange is under construction at Northwest 74th Street. Construction began in January 2007 and is scheduled for completion in the spring 2010. Approximate cost: \$64.8 million.

BROWARD COUNTY

TURNPIKE RESURFACING – COUNTY LINE ROAD (MILEPOST 47)

- A lane in both directions may be closed periodically on the Turnpike, approximately one mile north and one mile south of (Milepost 47) from 10 p.m. to 5 a.m. Monday, August 10, through Friday, August 14.

TURNPIKE WIDENING – GRIFFIN ROAD TO SUNRISE BOULEVARD (MILEPOST 53 to 58)

- One to two lanes in both directions will be closed periodically on the Turnpike between Griffin Road (Exit 53) and Sunrise Boulevard (Exit 58) from 10 p.m. to 5 a.m. Monday, August 10, through Friday, August 14.

Local highway affected:

- Turnpike northbound and southbound drivers will not be able to access the I-595 westbound ramps. The I-595 westbound ramps will be closed intermittently Monday, August 10, through Friday, August 14, from 10 p.m. to 5 a.m. A detour will be signed when this closure is in place.
- One to two lanes in both directions will be closed on I-595 in the westbound direction on Monday, August 10, through Friday, August 14, from 10 p.m. to 5 a.m.

TURNPIKE WIDENING – SUNRISE BOULEVARD TO ATLANTIC BOULEVARD (MILEPOST 58 to 66)

- One or two lanes in both directions will be closed periodically on the Turnpike between Sunrise Boulevard (Exit 58) and Atlantic Boulevard (Exit 66) from 10 p.m. to 5 a.m. Monday, August 10, through Friday, August 14.

Local ramp affected:

- The Commercial Blvd, SunPass only, single, southbound ramp entering Florida's Turnpike is closed around the clock. This ramp closure will be in effect until late October.

Local roads affected:

- Periodic, off peak, night time lane closures in both directions on Commercial Blvd from August 10, through Friday, August 14.

PROJECT DESCRIPTION: This project is a multi-million dollar construction program to widen Florida's Turnpike in Broward County. The first phase is in its third year of construction on the southbound lanes from Griffin Road (Exit 53) to Atlantic Boulevard (Exit 66). Approximate project cost: \$265 million.

PALM BEACH COUNTY

TURNPIKE INTERCHANGE RECONFIGURATION – LAKE WORTH ROAD (MILEPOST 93)

- Single lane closures in both directions on the Turnpike will take place approximately three miles south and one mile north of the Lake Worth Interchange (Exit 93) from 9 p.m. to 5 a.m. Monday, August 10, through Friday, August 14.

Local roads affected:

- Periodic, off peak, night time lane closures in both directions on Lake Worth Road from August 10, through Friday, August 14.

PROJECT DESCRIPTION: This project is an interchange reconfiguration at the Turnpike's Lake Worth Interchange (Exit 93) which will split the existing plaza, providing separate access for northbound and southbound drivers. Approximate project cost: \$17.5 million.

TURNPIKE MAINTENANCE – OKEECHOBEE BOULEVARD (Exit 99)

- One or two lanes in both directions will be in the vicinity of the Okeechobee Blvd Interchange (Exit 99) from 9 p.m. to 5 a.m. Monday, August 10, through Friday, August 14.

Local ramp affected:

- The Commercial Blvd, SunPass only, single, southbound ramp entering Florida's Turnpike is closed around the clock. This ramp closure will be in effect until late October.

ST. LUCIE COUNTY

TURNPIKE IMPROVEMENT PROJECT – FT. PIERCE (EXIT 152) & St Lucie (EXIT 142)

- None to report this week.

PROJECT DESCRIPTION:

Two improvement projects will be underway in St. Lucie County. The Port St Lucie (Exit 142) northbound interchange ramps will be resurfaced and realigned. This project begins in July and is projected to be complete in October. The second project is an improvement of the northbound off ramp at the Ft Pierce interchange (Exit 152). The ramp is being realigned. This project started in June and is projected to be complete in December. Combined costs for these two projects are approximately: \$2.8 million.

INDIAN RIVER COUNTY

TURNPIKE IMPROVEMENT PROJECT – (Milepost 173) to (Milepost 179)

- Periodic daytime off peak lane closures will take place on the northbound and southbound sides of the Turnpike between milepost (173) and milepost (179) Monday, August 10, through Friday, August 14.

PROJECT DESCRIPTION:

Resurfacing and safety improvement will take place on the Turnpike between Ft Pierce area and Fort Drum Service Plaza. This project starts this August and is projected to be complete in January 2010. Cost for this project is approximately: \$4.3 million.



Florida's Turnpike Enterprise is part of the Florida Department of Transportation overseeing a 460-mile system of limited-access toll highways: *THE FLORIDA'S TURNPIKE, EXTENDING NORTH FROM HOMESTEAD IN MIAMI-DADE COUNTY TO WILDWOOD IN SUMTER COUNTY, THE SEMINOLE EXPRESSWAY AND SOUTHERN CONNECTOR (TOLL 417) IN SEMINOLE, ORANGE AND Osceola COUNTIES, THE BEACHLINE EXPRESSWAY WEST (TOLL 528) IN ORANGE COUNTY, THE POLK PARKWAY (TOLL 570) IN POLK COUNTY, THE VETERANS EXPRESSWAY AND SUNCOAST PARKWAY IN HILLSBOROUGH, PASCO AND HERNANDO COUNTIES (TOLL 589), THE SAWGRASS EXPRESSWAY (TOLL 869) IN BROWARD COUNTY, AND THE Daniel Webster Western Beltway Part C (Toll 429) in Orange County.*

SunPass is the Florida Department of Transportation's innovative Prepaid Toll Program. SunPass can be used on Florida's toll roads and most toll bridges.
