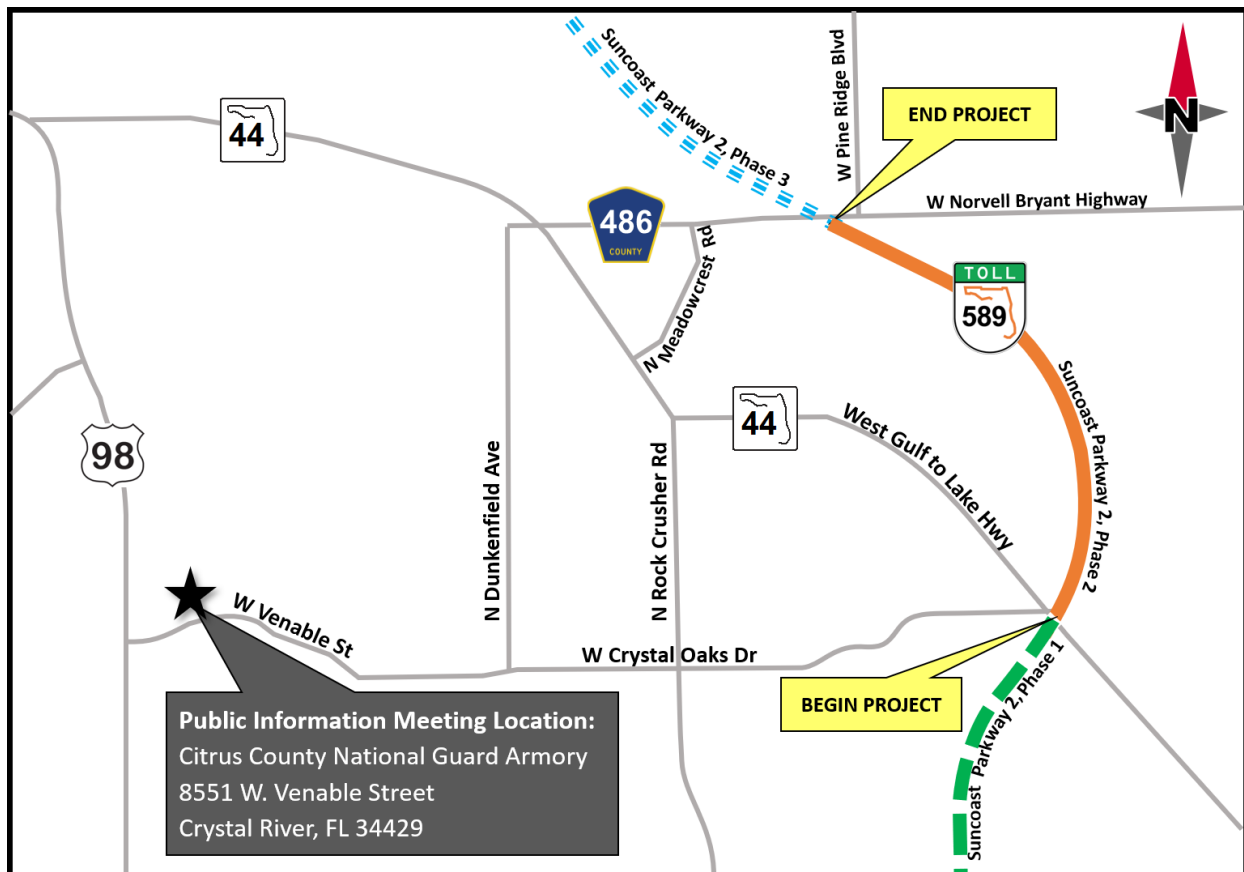

The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise (FTE) will hold a Public Information Meeting for the design of Suncoast Parkway 2 (SR 589), Phase 2, a new limited access tolled roadway from SR 44 to CR 486, in Citrus County, Florida (Financial Project Identification Number (FPID): 442764-1). The Public Information Meeting will be held on **Thursday, September 19, 2019 at the Citrus County National Guard Armory, located at 8551 W. Venable Street, Crystal River, FL 34429**. The meeting will be an informal open house from **4 p.m. to 7 p.m.** There will be no formal presentation. In the event the Public Information Meeting cannot be held on September 19, 2019 due to severe weather or unforeseen conditions, it will be held on the alternate date of October 17, 2019 at the same time and place.

This Public Information Meeting will give interested persons an opportunity to ask the project team questions and provide comments. Displays illustrating alternatives for the proposed design will be available for review. Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability, or family status.
